Legal frameworks such as the Palermo Protocol (2000) and national legislation in many countries have provided important definitions and guidelines for prosecution and victim protection.

Results and Discussion: Despite international efforts, challenges persist due to corruption, insufficient victim identification, and lack of rehabilitation programs. Studies indicate that victims often experience severe physical and psychological trauma, leading to long-term social exclusion. The literature also stresses the need for data-driven policymaking, awareness campaigns, and stronger socio-economic support systems to reduce vulnerability.

Conclusions and Recommendations: To combat human trafficking effectively, a multidisciplinary and multi-stakeholder approach is required. This includes strengthening international cooperation, enhancing border control, empowering at-risk populations through education and employment, and providing long-term rehabilitation
